This clinic will be offering the opportunity for 8 private 40 minute Dressage Lessons with FEI Dressage Judge General Stephen Clarke. **Priority for clinic rides will be given to active ADU members. *Application deadline is received by September 1, 2018.*** Only 1 horse per rider will be considered. We will keep a waiting list of reserve riders/horses in case the original teams end up not being able to attend. Higher level horses will likely be scheduled earlier in the day than lower level horses. \*No Dogs Allowed.

**CLINIC Lesson Fee Monday Oct 29:**

**ADU Members:**        \$200 + \$40 stall fee (priority will be given to active ADU Members)

**Non-ADU Members:**    \$250 + \$40 stall fee

Includes stabling *Sun eve-Mon eve*, stall mats, 2 bags of shavings, and a rider gift bag.

Additional shavings \$10/bag or you may bring your own.

Additional tack stall if desired is \$30.

RV hookup fee \$50/night
